



YOUR GUIDE TO MIGHTY LIABILITY NEW ZEALAND



Whilst "liability cover" insurance can be purchased from a third party* to protect you from cost of any liability in case of damage, it does not directly release you from the liability associated with hiring a Mighty vehicle.

It is a mandatory requirement for you to accept liability directly with Mighty by way of a liability deposit to cover the standard liability applicable to the Mighty vehicle hired.

The standard Mighty liability option is included in the rental rate and requires a liability deposit of NZ\$3,500 for the Jackpot and Double Down and NZ\$5,000 for all other campervans. This amount is debited to the hirer's credit card at vehicle collection and is refunded at drop-off provided the vehicle is returned undamaged. In the case of vehicle or property damage, part or all of the liability deposit will be retained, however you can seek reimbursement from the third party* from whom you purchased the liability cover insurance.

This liability can be reduced by purchasing the **Liability Reduction Option** or the **Mighty Inclusive Pack** in addition to the vehicle daily rental rate.

The credit card holder must be present and able to sign for the Liability Deposit upon vehicle collection. The credit card holder is jointly and severally liable for any damage to the rental vehicle.

Personal injury is covered in most cases through Registration Third Party insurance. Mighty does not accept any liability for personal injuries sustained during the rental nor for any loss or damage to any personal belongings or property of the customer (or any person or entity related to the customer). Mighty strongly recommend that all people travelling in New Zealand take out personal travel insurance.

Where nil liability is present you are covered for single vehicle damage (except single vehicle rollover unless you purchase the Inclusive Pack), third party accident and cost for repair/replacement of unlimited windscreen and tyres. In New Zealand it is not compulsory for drivers to have private insurance on their own vehicles. Any breach of the exclusions will render all cover void.
